Tuition Policies

Dance School Year 2020-21

There is an annual registration fee payable at the time of registration.

- 5% discount for pre-payment of entire semester tuition (August – December/January – June). Must be paid by the first month of the semester to qualify for discount. There are no refunds on tuition.
- Payment can be made by cash, check, debit, or credit card. Automatic debit/credit card payment plan is available.
- Monthly tuition remains the same regardless of whether there are five, four or three classes each month. Each class will average at least four classes per month during the course of the year.
- Tuition is due on the first of each month. A late fee of \$15.00 will be applied if tuition is paid after the fifth of the month. Automatic debit/credit card payment plan is available.
- There is a \$30.00 fee for returned checks. In addition, \$15.00 late fee will be applied.
- After second late payment, enrollment in automatic payment plan is required or student will be withdrawn from class.
- Make-up classes must be completed within 60 days of the missed class.
- There are **NO REFUNDS** for missed classes or for costume deposits/payments.
- Month to month contracts must notify the front desk if you are dropping a class. You will stop being billed no less than 30 days after your written notification.
- Semester and annual contract accounts will be billed monthly tuition through the duration of your contract.
- All recital fees, costume deposits, and costume balances are 100% non-refundable.
- *Unlimited class tuition does not include private lessons. Certain other exceptions will occur and will be addressed as they arise.
- In the event of any legal action or proceeding brought by either party against the other arising out of this agreement, Pinnacle Dance North retains the right to recover all reasonable attorneys' fees and costs (including, without limitation, court costs and expert witness fees, etc) pursuant to any judgement rendered in any such action or proceeding.

Other Fees:

**A non-refundable costume deposit of \$50 per costume (one costume per each spring class) is due at the time of registration. The remaining, non-refundable costume balance will be invoiced to you and due in November. (More information will be provided in late Fall)

**Recital fees of \$35 per dancer for Fall, and \$60 per dancer for Spring will be due at registration.
